

Tripura IT/ITeS Start-up Scheme

With a vision to create support eco-system for setting up of IT/ITeS Start-up Industries in the State to encourage the youths of the State to become an entrepreneur and to create employment avenues, the Directorate of Information Technology, Government of Tripura has introduced Tripura IT/ITeS Start-up schemes through Tripura Gazette Extraordinary Issue dated October 30, 2019. Standard operational guidelines (SOP) for disbursement of incentives under the scheme have been published on 15th July, 2020. Through this initiative the State Government aims to empower Startups to grow through innovation and design. Applications in the prescribed format have been received from 5 Start-ups. Webinar has been conducted at regular interval with the students of NIT, TIT, ICFAI University along with local entrepreneurs and NASSCOM.

Mukhyamantri Yuba Yogayog Yojana

Government of Tripura has started this scheme with the objective of providing smartphones to the final year students to empower them digitally and help them leverage the advantages of an interconnected world. Under this scheme, a grant of Rs 5000/- each is being provided to final year college students for purchase of smartphone. Total 8893 numbers of final year college students of 38 Colleges/Institutes/Tripura University have applied for the scheme during the academic year 2019-20. Out of 8893 applicants, 7286 numbers of applications have been approved in the National Scholarship Portal. Payment has been made to 7286 students as on date.

Application Development

More than 80 websites and 17 applications of various Department/Organisation of the State have been developed by Directorate of Information Technology (DIT), Govt. of Tripura as on date as a tool to reach out to the citizens. More numbers of development of websites and application are also in progress. 71 numbers of websites of various State Govt. Departments/Directorates/Organisations/Colleges of Tripura including the State Portal of Tripura are being maintained by DIT.

Digital Seva(e-District)

Digital Seva (e-District) is an online service delivery platform. It has been implemented in the State to deliver citizen centric services online. 44 Numbers of high volume services are being provided through Digital Seva (e-District) online platform (edistrict.tripura.gov.in) till 31st January, 2021. These services are integrated with Digital Signature (DSC), SMS gateway, email gateway, payment gateway, CSC, CSC wallet, UMANG, DigiLocker etc. More services have been planned to onboard under this platform.

e-Office

e-Office is aimed to conduct the office procedures electronically for a simplified, responsive, effective and transparent working in government offices. It is a mission mode project under the flagship Digital India (DI) programme. 14 Departments/Organization/Offices including Directorate of Information Technology (DIT), Planning (P&C) Department, DM Office, West Tripura, Finance Dept & PWD(R&B), Taxes & Excise organisation have implemented eOffice in the State till 31st December, 2020. Training and demonstration on eOffice were also conducted for about 100 Govt. officials. More training will be conducted under Capacity Building.

Tripura State Data Center (TSDC)

Tripura State Data Center (TSDC) was operational 24x7 basis since 24th Dec 2010. TSDC is providing data centre services/cloud service to different Departments/Organizations/Offices for hosting, running and storing their applications for delivering services to citizens. Currently, around 66 applications and around 110 websites of different State Govt. Departments/Organizations are hosted and running from TSDC till 31st December, 2020. Work is in progress to shift TSDC to new Data Center at IT Bhawan. Nine numbers of Web applications are hosted in TSDC during JULY to December, 2020.

Digital Seva transactions and Digipay transactions of CSC

CSC-SPV in collaboration with National Payment Corporation of India (NPCI) and IndusInd Bank has launched Aadhaar Enabled payment System (AePS) at all CSC locations across the country. The purpose is to achieve inter-operability between banks for Aadhaar based payment transactions. The DIGIPAY application will enable CSCs to cater the need of financial services in far flung and banking deprived areas of the country. 41,011 numbers of Digipay transactions had been recorded with value of Rs. 9,74,06,100/-in Tripura during October to December, 2020.

CSC Grameen e-Store

CSC Grameen e-store is a ground-breaking e-Commerce initiative by CSC SPV to promote digital ordering and delivering safely to the consumer doorstep. CSC had nine hundred (approx) numbers of active VLEs across Tripura and already more than six hundred and forty numbers of VLEs are registered with the CSC Grameen e-store and started delivering the products to the rural areas of the State.
