## Seminar on "Promotion of IT Sector in Tripura and IT/ITeS Start-up Scheme "

A Seminar on "Promotion of IT Sector and IT/ITeS Start-up Scheme in Tripura" has been organised by Directorate of Information Technology, Govt. of Tripura at auditorium of international exhibition center, Hapania on 12th February, 2020 during the 30th Tripura Industries and Commerce Fair-2020. Sri Tinku Roy, Hon'ble Chairman, Tripura Industrial Development Corporation Limited (TIDC) has inaugurated the program in presence of Director, IT, Govt. of Tripura and other dignitaries. One hundred & sixty (160) numbers of students from various technical institutes of Tripura, professors, entrepreneurs and IT Nodal officers of State Govt. Departments have attended the seminar. In the seminar, the Tripura IT/ITeS Start-up Scheme, 2019 along with the scope of IT Start-up Industries in Tripura have been discussed by the resource persons from State e-Governance Mission Team (SeMT), Software Technology Parks of India (STPI), National Institute of Technology(NIT) Agartala and Directorate of Information Technology (DIT), Govt. of Tripura,. In this occasion, few entrepreneurs of Tripura had also shared their experiences with the students.

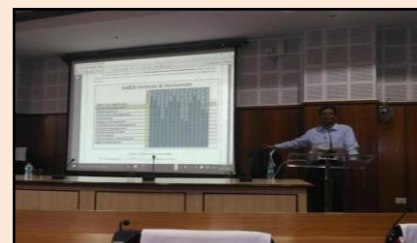
## Training program on Blockchain



Blockchain is a self-sustaining, peer-to-peer database technology for managing and recording transactions with no intermediaries' involvement. 1-day training program on Blockchain, organised by Directorate of Information Technology, Govt. of Tripura in collaboration with NISG (National Institute for Smart Government) has been completed successfully at Pragna Bhaban, Agartala on 14th January, 2020. In the program, the key concepts of Blockchain along with the Blockchain solution in Government (land records, identity, health records) and industries (banking and insurance industry and smart cities) have been discussed by the resource persons from NISG. IT Nodal officers of State Govt. Departments have attended the training program.

## Training program on Digital Governance

Digital governance in India has steadily evolved from computerization of Government Departments to initiatives that encapsulate the finer points of Governance, such as citizen centricity, service orientation and transparency. 1-day training program on Digital Governance, organised by Directorate of Information Technology, Govt. of Tripura in collaboration with NISG (National Institute for Smart Government) has been completed successfully at Pragna Bhaban, Agartala on 28th January, 2020. Officials and IT Nodal officers of State Govt. Departments have attended the training program. In the program, the vision areas and pillars of Digital India, implementation approach of Digital India to improve efficiency, transparency, accountability and trust in governance and challenges of Digital Governance have been discussed by the resource persons from NISG.



## Website Development

The official website for Factories & Boilers Organisation, Govt. of Tripura (<https://factory.tripura.gov.in/>) has been developed by Directorate of Information Technology, Govt. of Tripura (DIT) during January to March, 2020. Seventy-three (73) numbers of websites of various State Govt. Departments/Directorates/Organisations/Colleges of Tripura including the State Portal of Tripura are being managed by DIT.

## Workshop on Digital MSME Scheme



CSC e-Governance Services India Limited (CSC-SPV) has been selected as the implementation agency for the Digital Micro, Small and Medium Enterprises (MSME) Scheme. A State level workshop on the scheme had been successfully conducted on 13th March 2020 in Pragna Bhawan, Agartala. The event was organized by state team of CSC-SPV in collaboration with Department of Industries & Commerce, Govt. of Tripura and Ministry of Micro, Small and Medium Enterprises. CSC district managers, officials from Industries & Commerce, Taxes and Excise Organisation, Govt. of Tripura, Banks, MSME & Village Level Entrepreneurs (VLEs) of CSCs had participated in the event.

## Common Service Center

As on March, 2020, total 1227 numbers of Common Service Centers (CSC's) have been registered in Tripura. Out of 1227 numbers of CSC's, 932 CSC's are at Gram Panchayat (GP) level. 49461 numbers of digital seva transactions have been recorded with value of Rs. Rs. 1,99,97372/- and 5331 numbers of digipay transactions have been recorded with value of Rs.1,22,75600/-in Tripura during January to March, 2020. Government of India has introduced a pension scheme for unorganised workers namely Pradhan Mantri Shram Yogi Maan dhan (PM-SYM) on 15 February, 2019 to ensure old age protection for unorganised workers. In Pradhan Mantri Shram Yogi Maan dhan (PM-SYM), total 25,500 numbers of beneficiaries have been registered and in PMJAY/Ayushman Bharat, total 3,04,594 numbers of beneficiaries have been verified through CSC in Tripura till March, 2020. 4070 numbers of Tele Law Cases have been registered and legal advices have been provided through CSCs in Tripura during January to March, 2020. This e-interaction between lawyers and people was provided through the video-conferencing infrastructure available at the CSCs.
